To celebrate the establishment of Northern Ireland's first licenced Whiskey Distillery in over 125 years an inaugural distillation of 144 premium casks will be made available to whiskey connoisseurs and collectors.

These limited edition casks will be known as **'The Patron's Promise'**.

Each Patron will have an array of options from whiskey style and cask size to age and finish. There is a choice of Irish Pot Still or Single Malt and a variety of barrel options to mature the new fill spirit. Once matured for a minimum of five years the whiskey can be finished in a range of speciality casks including Pedro Ximenez and Oloroso.

The whiskey produced at Echlinville is truly special and can be traced from field to bottle. The barley is grown on the surrounding fields and floor malted on site to produce a whiskey that is true of character and exceptional in quality. This with the use of only the highest quality barrels, time and patience of the distillers, work to make a spirit that contains a complex array of flavours and characteristics that are unique to Echlinville.

TERMS & CONDITIONS

These Terms and Conditions govern the sale of goods by us and will form the basis of the Contract between Echlinville Distillery Ltd (EDL) and you. Before submitting your Order, please ensure that you have read these Terms and Conditions carefully. If you are unsure about any part of these Terms and Conditions, please contact us for clarification. Nothing provided by us including, but not limited to, sales and marketing literature, price lists and other documents constitutes a contractual offer capable of acceptance. Your Order constitutes a contractual offer that we may, at our discretion, accept. A legally binding contract between us and you will be created upon our acceptance of your Order, indicated by our Order Confirmation. Order Confirmations will be provided in writing.

- 1: On receipt of a completed and signed application form and full payment for the ordered Patron's Promise cask(s), an Order Confirmation will be provided, your cask(s) allocated and the title for the cask(s) will transfer to the named purchaser.
- 2: Title to the purchased casks will lie with the purchaser. The Distillery must be notified in writing of any subsequent transfer or trading of title by the purchaser.
- 3: A receipt, countersigned copy of the application form and stock certificate will be issued to the purchaser on completion of the order transaction.
- 4: Each cask ordered will be filled with our special reserve new fill spirit and will be at a strength of 63.5% ABV. The casks will be warehoused under bond at The Echlinville Whiskey Distillery, Kircubbin County Down, the Distillery and the purchaser having agreed the terms herein.
- 5: Prices include warehousing for 5 years from the date of filling of the purchased cask(s) but excludes VAT and Excise Duty.
- 6: A payment plan may be offered on application; however, title of the cask(s) will not transfer until final payment has been received.
- 7: Patron's Promise Casks are insured against fire, theft and spoilage.
- 8: The minimum term for maturation is 5 years. Patron's Promise casks will remain under-bond for a minimum of 5 years unless otherwise agreed between both parties.
- 9: The purchaser is obliged to give 1 month's advance notice to the distillery before removing their cask(s) from bond. Normal bonded warehouse procedures apply.
- 10: The purchaser is solely responsible for any shipping costs, VAT, excise duty and any other taxes caused by the removal of their cask(s) from our bonded facilities. These costs must be paid before removal of the cask.
- 11: Maturation for the Patron's Promise Programme will be defined as 5 calendar years from the date of filling of the purchased Cask(s).
- 12: The Distillery must be given 6 (six) months' notice in writing should the purchaser's circumstances change in that they want to dispose of the cask and the distillery may enter into discussions about such arrangements in the first instance.
- 13: Point 12 above shall be available to the purchaser for 6 (six) months from the maturation date of the cask(s).

STORAGE

- 14: Continuance of warehousing will be provided by arrangement. For each additional year's warehousing, the purchaser will be charged a warehousing fee.

CASK VISITS

- 15: You are welcome to visit your cask and this must be done strictly by appointment only. We request 5 working days notice for any cask visit. Echlinville is a working distillery and visits will not be possible at times due to production or annual leave scheduling.

BOTTLING

- 16: The purchaser may choose to have their cask(s) bottled 5 (Five) years after the fill date. Bottling cost can be agreed at any time unless special pre-paid bottling offer is acquired. Please see order form for details.
- 17: All bottled Patron's Promise Whiskey, (whether in standard or personalised bottles), must have attached to the bottle a label which prominently displays The Echlinville Whiskey Distillery.
- 18: Patron's Promise purchasers that wish to avail of the Distillery Buy-Back Scheme may do so provided the maturation period has passed & the purchaser has provided The Echlinville Whiskey Distillery with 6 months written notice. EDL reserves the right for first refusal (to purchase) on any casks traded as part of this offer.
- 19: Any Patron's Promise cask order produced outside The Echlinville Distillery's standard range of liquids or that has been specially blended is not subject to the terms and conditions of the buyback scheme. All special requests must meet the Echlinville Distillery minimum standards of production.
- 20: Under any cask Buy-Back Scheme, The Echlinville Distillery will apply 3.5% compound interest per annum on the purchase price of the cask & for the duration of the cask's maturation.

ANGEL'S SHARE

- 21: A little evaporation takes place through the wood as whiskey matures in the oak casks – this is known as the 'angels share'. At the same time, the strength (ABV) decreases slightly. We have allowed for a 2% loss (decreasing) year on year and this is reflected in the prices quoted for whiskey being bottled after 5 years. The purchaser acknowledges and agrees to this and no claim shall be made against Echlinville Distillery for any loss of value in the Whiskey or decrease in quantity due to the effect of the Angel's Share.
- 22: The Echlinville Distillery will assume that the purchaser is happy for the ageing of their whiskey to continue in our warehouses after the five year maturation period until we have been notified. The costs here after will be charged at a rate of £65 per cask per year and will include insurance. This figure will increase in line with the current rate of UK inflation.

NOTES:

- 1: No guarantees are given by Echlinville Distillery Ltd to the compensation paid out by insurance companies if a total loss occurs.
- 2: It is the responsibility of the cask owner to advise The Echlinville Distillery of any changes in address.
- 3: Any casks of our whiskey not bottled at Echlinville will not be permitted to carry the 'Echlinville' or 'Patron's Promise' logo. Only the wording 'Single Malt' produced at the Echlinville Distillery, Kircubbin, Co. Down, N. Ireland is acceptable.

GOVERNING LAW AND JURISDICTION

These Terms and Conditions (and the Contract) (including any non-contractual matters and obligations arising therefrom or associated therewith) shall be governed by, and construed in accordance with, the laws of Northern Ireland.

Any dispute, controversy, proceedings or claim between us and you relating to these Terms and Conditions (or the Contract) shall fall within the jurisdiction of the courts of Northern Ireland.
